Good afternoon Rebecca,

I hope you are well and the annotated plans as previously requested are coming along. Please do let me know if you think these may not be submitted before the end of the week so that we may agree to a further EOT as required.

My manager has reviewed my report and is happy with the officer's recommendation to approve, subject to conditions. One standout point that we need to agree between ourselves is the application description, as apparently there is no such land use as C2/sui generis. This isn't a problem – please could you just confirm by way of response to this email that you are happy to for us to amend the application description to correct this error (essentially to remove the reference to sui generis), and I shall update all relevant documents (namely just the application form and our website). The amended application description would read as follows:

“Proposed change of use from Fire Brigade Training Centre (Class F1(a)) to Children's Emergency Accommodation (Use Class C2 - Residential Institution) with associated parking.”
