

To whom it may concern,

I am writing in regard to my strongly held disagreement of the application to increase tonnage of waste disposed by Recycle Southern Ltd, who's business is located directly behind my home.

Since moving to the property in 2014, my respiratory health has severely been affected. I have always been asthmatic, but this has significantly worsened. I have now been diagnosed with COPD and have been prescribed steroids, the dosage of which has been increased on more than one occasion. I have never smoked and have always led a healthy outdoors lifestyle; therefore, I can only deduce that the cause of this is environmental, namely the dust clouds omitted from the Recycle Southern Ltd site. I strongly suspect this would contain asbestos and carcinogenic properties. I fear I am not the only member of my family, that's health has been detrimentally affected, in the form of cancerous skin conditions, allergies, and their own respiratory decline. I consider this to be a direct assault of my person, for which I am considering claiming for through personal injury. I have began investigations though legal advice.

Health is not my only concern, the incessant dust ploom that blows across my property and settles on every surface within my home, on my cars and on my animals is impossible to stay on top of. I am registered disabled as are the other members of my family and we are physically, mentally, and emotionally drained from the effort and time that is consumed, daily, by cleaning, in attempt to get rid of the dust.

Recycle Southern currently state on their website that, they have a license of to manage up to 75000 tonnes of waste per annum. My belief is that this is the amount they were applying for and had yet to be approved by the council. My concern now is that any license granted may exceed this amount. I do not believe they are taking the appropriate and legal actions, precautions, and responsibilities to mitigate the impact of their business on the environment, their social surroundings, and the wellbeing of their neighbours. I do not believe they have an effective dampener system. I have been reliably informed that this should consist of some sort of sprinkler system running the full length of the perimeter of the site. The only evidence I have ever seen is an employee driving a tractor and throwing

the occasional bucket of water. Their dumping site and skips are pressed up against my fence and on occasion I have witnessed the grab lorry miss the skip entirely and dispose of the waste over my fence.

In light of the severe detrimental impact to mine and my families health, wellbeing and living standards. The environmental damage and my right to a private and family life in accordance with Article 8 of the Human Rights Act 1998. I would like to see this application rejected altogether or at the very least the deadline for this decision to be postponed in order for me to gather further evidence of the intolerable situation in which we find ourselves living, due solely to the conduct of Recycle Southern Ltd.
