**1. Property: Brookhurst Landfill Site, Langhurst Wood Road**

**Proposal: Construction and operation of a materials recycling facility, including offices and visitor centre, an anaerobic digestion plant, and extension to an existing landfill site, and ancillary infrastructure (Variation of Condition 2 of planning permission WSCC/067/19 for a 12 month extension to the end date to complete restoration of the landfill)**

**Decision: The Parish Council have no objections to the planning application. But would like to see the wording changed from rich grassland to *Species rich grassland*. The idea is that this Species Rich Grassland will filter as a reservoir for wildlife for the whole of the community. Following the changes to the wording, the council seeks approval for this application.**
