Hello James, I'd confirm the details submitted are acceptable in principle subject to further approval by the Area Office. I would though offer the following advice.

Condition 12 (Routing)

Routing to/from the north is preferred, although this routing would only be advisory as there is no traffic regulation order to make any restrictions enforceable. I doubt that temporary directional signage would be required, but this could be considered if necessary.

I also can't open the drawing showing the proposed signage. This is something though to be agreed between the Applicant and the Area Office.

Condition 13 (Signage)

All of these details need approval from the Area Engineer. I would suggest that the 'Men at Works' sign isn't appropriate as this relates to temporary obstructions within the carriageway,; there are no temporary obstructions as the access is existing and there aren't any temporary works as far as I'm aware. The merging works traffic signage may also need to be considered as I don't know if this is appropriate. But these are things that can be answered by the Traffic Engineer at Broadbridge Heath.

Condition 14 (wheel washing) No problems with the strategy suggested.


