Appendix 1

Recommendations of the Planning & Services Committee meeting held on Thursday, 9th January 2020

DC/19/1803 - 31 Glebelands Pulborough (CE)

Erection of a two-storey rear and side extension and single storey front extension with balcony over. (Amended Plans). No objection – however, the Council has concerns regarding the potential for over-development in the area.

DC/19/2515 & 2516 - Old Rectory Old Rectory Lane Pulborough (EK)

Erection of a building to cover swimming pool located in the rear south facing garden, together with a lightweight timber pergola walk (Householder & Listed Building). No objection, but concern raised over location of plant room and any noise emitting from it.

DC/19/2495 - Hill Copse House Hill Farm Lane Codmore Hill Pulborough (JW)

Outline planning application for the demolition of a residential outbuilding and the erection of a single dwelling, creation of new access from Hill Farm Lane with all matters reserved except access – see copy email from local resident. Members noted that there is an inaccurate description of the swimming pool enclosure, which is described as a residential outbuilding. Also, having spoken to the applicant, Members would like to point out that the application form does not describe the correct dwelling that is being proposed by the applicant. Therefore, Members OBJECT to the application that has been submitted and would suggest the applicant re-submits the application with the correct information.

DC/19/1860 - Middle Barn Farm Coombelands Lane Pulborough (EK)

Equestrian Development for personal use comprising of a partially submerged barn for stables, feed store and machinery; outdoor school, horse exerciser and associated hardstanding. Retrospective consent for resurfacing an existing access (Resubmission of application reference DC/18/2340). (Amended Plans). No objection, however, Members note HDC's recommendations by Barbara Wise to position a smaller barn to the east of Middle Barn Farm, which will have much less visual impact.

DC/19/2532 & 2533 - Ebbsworth Cottage The Street Nutbourne Pulborough

Erection of a single storey rear extension, external and internal alterations and replacement of roof covering with plain handmade clay tiles (Householder & Listed Building Consent). No objection to the erection of a single storey rear extension and internal alterations, but OBJECTION to plain handmade clay tiles, the thatch should remain.

WSCC/078/19 - Wood Barn Farm, Adversane Lane, Broadford Bridge, Billingshurst, West Sussex (JW)

Amendment of condition no. 1 of planning permission WSCC/033/18/WC to enable the retention of security fencing, gates and cabins for a further 24 months. Objection – 24 months is too long. Members noted that on WSCC's website there are 50 letters in support of this application, although none of these are from within the Horsham district. Any letters outside the Horsham District should not be considered.

WSCC/079/19 - Wood Barn Farm, Adversane Lane, Broadford Bridge, Billingshurst, West Sussex (JW)

Amendment of condition no. 1 of planning permission WSCC/032/18/WC extending the permission by 24 months to enable the completion of phase 4 site retention and restoration. Objection – 24 months is too long. Members noted that on WSCC's website there are 50 letters in support of this application, although none of these are from within the Horsham district. Any letters outside the Horsham District should not be considered.

<u>DC/19/2481 - Architectural Plants Limited Stane Street North Heath Pulborough (BK)</u> Regularisation of use of mobile cabin for security personnel. **No objection.**

<u>DC/19/2529 – Swift Cottage, Barn House Lane, Pulborough</u> Surgery 2 x Beech. **No objection.**

DC/19/2588 - Swift Cottage, Barn House Lane, Pulborough

Surgery to 4 x Leylandii (Works to Trees in a Conservation Area). No objection.
