Afternoon Nigel,

If you consider a decision on your planning application is urgent and would affect the applicant's business if it not determined soon, we can consider taking it to a 'virtual' planning committee for June 9th. Hi Nigel,

The council are currently looking into options for carrying out virtual meetings/tele-conferencing, including for planning committee, but nothing has yet been agreed, nor tested.

Can you let me know if there is an urgent need for the decision, for example, is it going to affect UKOG's business if it were not to be determined in May? In essence, if there's not an urgent need for the decision, it would be sensible to delay it to a later meeting.

If the concern was regarding enforcement matters, we are aware that the time period for the restoration has now expired (31st March 2020). However, given the current national situation and the fact that there is a current application with a recommendation for approval for extending the time period, I can confirm that WSCC are not currently looking to enforce against the site with regards to this matter.
