Hi Dan,

As you're aware, the Planning and Rights of Way Committee determined to defer the planning application at Evergreen Farm and as discussed this was to enable the exploration of certain issues. Namely;

 The need for the volume of inert material to be imported, including general fill in the areas currently designated for woodland and; Matters regarding highway capacity, road safety and traffic management measures, in the widest sense.

For example, instead of having areas where tree planting can take place (thereby requiring a greater depth of soils), would it be possible to simply have a metre cover over the site, and what would be the required import of material in this case? If a reduction is possible, this would clearly reduce the number of HGVs' to the site, therefore what would that reduction look like on a weekly basis?

In addition, the committee were interested in the possibility of extending the time period of operations, again thereby reducing daily HGV movements. Is this something which could be investigated and if so, what extended period could you work with?

Finally, the application received a large number of objections with regards to traffic issues, and the National Trust and the Town Council also had great concern regarding highways matters. A number of matters were raised as requests in their consultee responses (attached for ease). Aside from those matters recommended to be secured by planning condition, are there any matters which you're additionally able to employ to help alleviate local residents and neighbours concerns during the operation of the development?
