Objection

As a local resident living at Clymping slightly north of the Oystercatcher public house on the B2233 Yapton Road I object to the proposed incinerator plant at Ford on the following grounds; Infrastructure 1) Currently the existing road infrastructure barely supports demand. Morning and evening traffic at the junction where the B2233 meets the A259 frequently backs up. Any idea of turning right heading West towards Bognor Regis is pot luck with many vehicles opting to head East and doubling back via Climping Street . Church Lane and Ford Road are unclassified roads running parallel to the B2233. Their position is similar with congestion at the Church Lane Roundabout plus many additional Heavy Goods Vehicles (HGVs) heading to and from the Grundon / Viridor processing plant. With the proposed 1500 homes planned at Ford Airfield, and 300 proposed homes on the field bordering the A259 between Yapton road and Church Lane, a simple calculation using the Office of National Statistics figures for vehicle per home at 1.4 average it would be reasonable to assume a further 2520 vehicles are likely to be using these roads. If we extrapolate this to say each vehicle makes one trip per day out and in we have a further 5040 journeys, 2 Trips per day 10,080 journeys. Add into the mix a possible 400 plus HGVs per day to and from the proposed plant, truly a nightmare for residents and commuters is imminent. Pollution 2) Given the above can we seriously believe that the air quality will remain unaffected. Pollution is not confined just to air quality, we will also have to contend with vehicle noise, road debris etc. The following is an extract from environmental protection uk: Air pollution has a devastating impact on the UK population, shortening lives, causing early deaths and ill health. It is a bigger global killer than smoking. It costs the UK economy over 20 billion a year. Air pollution needs direct action by the UK government to address widespread sources of pollution (such as transport, buildings, energy and industry), supported by other levels of government tackling local hotspots and implementing solutions locally. This needs stringent, legally binding targets. I would suggest the council take note. We, our children, and our grandchildren should not be subjected to such risk. Finally on pollution I see a proposed chimney stack reaching some 85 meters into the atmosphere where allegedly the harmless bio products of processing will be released. I have to ask if so harmless why this height? Landscape 3) Following on from 2 this proposed blot on our landscape, West Sussex is a beautiful area with outstanding views for all. The thought of constructing a chimney which can be viewed for miles around is beyond belief. Clymping / Yapton/ Arundel would appear to matter little to companies who seem to be hell bent on returning us to the industrial age. This wanton disregard for our green spaces is abhorrent and should be challenged at every step of the way.
