#### **AERODROME SAFEGUARDING STATEMENT**

The West Sussex County Council (WSCC) "Local List for the Validation of Planning Applications" (June 2017) requires that an aerodrome safeguarding statement be submitted for applications within 15km of either:

- Gatwick Airport (co-ordinates 526677, 140322)
- Goodwood Aerodrome (co-ordinates 505133,0004533); or
- Brighton City Airport (Shoreham) (co-ordinates 508356, 0002972)

Approximate distances from the site of the proposed scheme (Phase 1 realignment of the A29 at Eastergate) are as follows:

- Gatwick Airport 45km
- Goodwood Aerodome 6.7km
- Brighton City Airport (Shoreham) 24.5km

Goodwood Aerodrome is the only site sufficiently close to the site to warrant consideration. The operators of Goodwood Aerodrome have been consulted on the scheme and have confirmed that they have no objection to Phase 1 of the A29 realignment on aerodrome safeguarding grounds. Good Afternoon,

I am emailing with regards to the proposed realignment of the A29 which is approximately 7.9km to the south-east of Goodwood Aerodrome. As the site is within the 15km safeguarding area designated by West Sussex County Council, we are consulting with you in order to establish if the realignment of the A29 would constitute a hazard to air traffic from Goodwood Aerodrome. Please note, the proposed realignment is currently at the design stage and no planning application has been submitted as part of this proposal. Any input you may have regarding Goodwood Aerodrome would be beneficial at this stage to inform our understanding of the potential impacts of the proposed realignment.

#### Location

The site is located to the east of Eastergate, Westergate and Woodgate villages, between the junction of the A29 Lidsey Road and the A29 junction with Fontwell Avenue (please see attached Figures 1.1 and 2.1 for a site location and red line boundary).

#### **Proposed Scheme Description**

The scheme would compromise a 30mph, 1.3km single carriageway with 3m wide cycleway and footway, 2.5m wide central island, four uncontrolled crossings, three roundabouts, landscaping, potential noise barriers and other associated works (please see Figure 1.2 for the proposed Scheme Alignment). It would tie into the A29 Fontwell Avenue to the north west and the B2233 Barnham Road to the south, with two new roundabouts. A third roundabout would provide access to planned residential areas. The current estimated site area is 11.4ha (excluding construction compounds, haulage and temporary access). The tallest structures will be lighting columns which are most likely to be 10-12m in height and are not expected to exceed a maximum height of 15m.
