My family and I live on Ford Road which is an area already not suitable for HGVs despite the copious that seem to pass through anyway. What we do need in this area is more pedestrian paths and cycle lanes and someone or something to enforce the prevention of HGVs coming down this already small residential road. We have children accessing two schools in the town from this area with no pedestrian crossing and an old people's home which seems like it'd be in danger and a surgery that requires those in town to cross Ford road

to get there. On top of that, an increase in traffic could block the fire station too, a service that I'm sure you would agree absolutely needs complete access to wherever it needs to be. Furthermore, our local surgery wouldn't be able to cope with such an increase in health issues as it is already stretched to its limit.
