WSCC ECOLOGY response to HRA Screening

Summary Response

This project will not have any significant adverse effect, either alone or in combination with other relevant projects and plans, on the integrity of any European designated site. Consequently, an appropriate assessment is not required.

<u>Response</u>

A Shadow HRA (March 2021) has been submitted by the Applicant which rightly identifies potential impact pathways on two European Sites, Duncton to Bignor Escarpment Special Area of Conservation (SAC) and Arun Valley Special Protection Area (SPA). Duncton to Bignor Escarpment SAC is included because it lies just within the 10km zone of influence commonly applied for screening. There are no other European Sites within 10km the Application Site at Ford, though the Arun Valley SPA is only just outside this zone. The Shadow HRA assessed impacts on the Arun Valley SPA, specifically Bewick's swan, given that linked sites elsewhere in the valley could be important to the wintering Bewick's swan population.

The plant is legally required to meet air quality standards, as regulated by the Environment Agency under an Environmental Permit. No additional mitigation measures have been included in the design of the plant to reduce impacts on European Sites.

The Shadow HRA considered potential impacts from dust, nitrogen oxides, sulphur dioxide, hydrogen fluoride and ammonia pollution on Duncton to Bignor Escarpment SAC. The conclusion that there were unlikely to be any significant effects from any of these appears to be correct and thus these potential air quality impacts can all be screened out.

As no sites in the Ford area are used regularly by the wintering Bewick's swans associated with the Arun Valley SPA, the Shadow HRA concluded that there were unlikely to be any significant impacts on the Arun Valley SPA. This is a reasonable assumption and thus potential impacts on the Arun Valley SPA can also be screened out. An assessment of potential in-combination effects from other projects and plans, including substantial housing allocations, has concluded that they will not be significant contributors to aerial pollution. Thus, one can conclude no likely significant effects on the interest features of European Sites from in-combination effects with other projects and plans.

In summary, this project will not have any significant adverse effect, either alone or in combination with other relevant projects and plans, on the integrity of any European designated site. Consequently, an appropriate assessment is not required.
