| Comments              | I continue to object to this planning application. The additional material submitted by Protreat on behalf of Loxwood Clay Pits does not address previously raised concerns. The application does not demonstrate the fundamental purpose which should be a need for additional clay in this area of West Sussex / Surrey. If clay is not needed, then there should be no need for a construction materials recycling facility. Construction, demolition, and excavation waste recycling is important, but should not be carried out in this site. It is a complicated, multi-stage process involving Feeding and prescreening; aggregate scrubbing; contaminant removal; metals removal; sand washing; aggregate sizing; primary stage water treatment; sludge management. These are activities on an industrial scale that are not appropriate for this site. The site is not suitable for industrial use and the idea of bringing material in to a remote, natural woodland for retreating, burial or removal for disposal elsewhere is absurd. In this day of concern about sustainability, carbon footprint, a drive to be carbon neutral, how can this activity be sanctioned? The application has a particular impact on me and my family who are neighbouring farmers with a boundary which runs alongside the boundary of the planning site. This is a most tranquil part of my farm and the Danhash's woodland. The site, on their land holding in Pallinghurst Woods, could not be further from a road - what is the sense in that unless they plan to start extracting clay from the furthest boundary and work back to the Loxwood Road. |
