Yes we are aware that the PC's are concerned about traffic and following our meeting with them, proposed a series of measures to try and allay their concerns. I recall in the planning application that we offered a series of measures (i.e. lighting systems, temporary parking restrictions around the Green and no HGV movements during school pick up/drop off hours) that effectively the Council could pick and choose from as they see necessary. I think the lights would only be used during daylight hours and during construction when there would be the most movements so they wouldn't be used at night as far as I'm aware.

I will ask our transport consultant to confirm this.
