I thought it would be helpful to provide an update of our consultations so far to address the concerns raised.

With regards to bats, we have had detailed conversations with the statutory consultees (WSCC and Natural England) and taken their views on board. We have actioned the measures we agreed with WSCC to design out any impacts on the SWT site including moving the Application Site 15m from the woodland edge to mitigate impacts - this is the same design shown on the plans at the public exhibition earlier this year.

We have also consulted with The Mens and Ebernoe Management Team, Sussex Biological Records Centre, Sussex Bat Group, the Sussex Ornithological Society and the Sussex Biodiversity Partnership as well as the West Weald Landscape Project. Our proposals are for a very small, temporary scheme in an arable field which does not involve fracking but the level of consultation in respect of wildlife and the project as a whole has been very thorough. We have had consultation with WSCC, CDC, statutory and non-statutory consultees, Councillors and local residents through the Scoping Report, face to face meetings, public exhibitions, presentations, press articles, our website, emails and a dedicated telephone line.

Our ecologists advise me that they originally contacted SWT on 26<sup>th</sup> April, who very kindly sent our ecologists a CD containing various reports on the foraging behaviour of bats associated with the SACs. Our ecologists have reviewed this data and incorporated it into their reports. SWT did not make any other comments on the scheme or request further information. We cannot pass on our ecology data just yet as we are still collating it but this will all be presented in the planning application which is due to be submitted in the next week or two.

We found out from a series of blogs and articles that Petra was concerned about the proposals, and our ecologists (who are best placed to discuss this topic) have taken steps to engage with SWT and to explain the scheme and to discuss enhancement measures. Our ecologists have been liaising with SWT since early July (email chains attached) and their initial email seemed quite positive about the work we were undertaking. We have been liaising with SWT on mitigation measures and are happy to continue liaising with parties throughout the planning process.

We have undertaken a thorough and meaningful process of pre-application consultation, all of which will be documented in the application.

Thank you for your email.

I would clarify firstly that we have not yet received a planning application.

The Parish Council was consulted on the EIA Scoping Request which considers what issues should be addressed in the Environmental Impact Assessment. Upon receipt of an EIA Scoping Request we only consult with the relevant statutory consultees (the Environment Agency, District Council etc.) and the Parish Council. We do not consult with neighbouring landowners, or organisations such as Wildlife Trusts (presuming this is what you are referring to with 'SWT').

I am happy to consult with SWT when (and if) the application comes in – and we would be required to do so if they own adjoining land.

Hi Jane,

I met Petra Billings from SWT this morning and was disappointed to learn that they were not originally consulted on the pending application given their ownership of the adjoining site, Northup Copse or that the level of meaningful consultation, now that SWT have become involved, is not all that it should be if the parties are to fulfil due process.

SWT will be a meaningful party to advising on ecological issues including mitigation requirements and whereas, I understand, the applicant is proposing some changes to the site layout details of such change or indeed the original plans the Parish Council's where consulted upon, have yet to be provided to SWT. Further it appears that Celtique's ecological survey material has also not been provided. It seems to me that unless such detail is provided to SWT in a timely manner it will be difficult for Celtique to substantiate a case for having carried out a meaningful pre-consultation prior to submission of the application.

I have copied Jenny in the hope that she will be able to assist in resolving this issue. Regards

Thanks for this. I think these are all good suggestions. Just a couple of thoughts - to my mind it would make sense to have the beetle bank dividing the field down the middle north/south rather than east/west so that it provides a parallel corridor to the eastern field boundary. Also, could you go further and suggest this as a native hedgerow with margins either side rather than just the beetle bank - this would further strengthen the connectivity of the landscape and provide an alternative bat flightline?

Thank you for the update. It's disappointing that the landowner is unwilling to implement the minor wildlife-friendly measures for the field we discussed post-drilling. I've spoken to colleagues about your offer to contribute to further research on The Mens bat population and we're not comfortable with the concept of research as mitigation or compensation for likely damage to wildlife populations at this stage of the process. The 2008 study demonstrates well the importance of flightlines to the Barbastelles and the 2011 survey shows that the flightline past the proposed drill-site continues to be actively used. Not having had details of the drilling proposal yet, we can't assess its impacts but if it impacts on the flightline use, as seems highly likely, we will object. If the plans are approved, we will of course seek mitigation at that stage but I'm not sure that further research would be sufficient.

In overview we think it would be premature of us to discuss these sorts of measures at this stage. Whilst we're happy to continue to liaise with you on this, we reserve our right to object to the plans if they affect the use of Northup Copse as a nature reserve or its wildlife populations, particularly such highly protected species as the bats.

Reference my previous email, as we've had no requests for access to Northup Copse, we assume your surveyors haven't begun work yet. I'd be grateful if they would contact either myself or Mark Monk-Terry, the Northup Copse Reserves Officer, to let us know when they wish to go.

Hi Petra ,

I just wanted to update you on the enhancement strategy for bats at Wisborough Green. We've spoken to the farmer and he doesn't feel that he can accommodate any of the enhancements that we discussed, as this would constitute a long-term commitment on his part. Obviously we are keen to provide something that would contribute to the conservation of bats from the SAC and I wondered if it might be appropriate to support some of the current research into bat foraging habits, as this would further the studies that the West Weald Partnership has already started.

I've just been looking at the 1997-2008 study on the status of barbastelle bats and I note that it recommends some further studies. As these studies are designed to map the key commuting routes and foraging areas for the SAC bats and this in turn can be used to target conservation measures and inform planning policy, a contribution to this scheme would be of benefit to the bat population in the long-term. Are you planning to conduct any further research on The Mens bat population in the near future?
