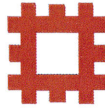

Thankyou for your letter of 15 May 2014 notifying us of the above application for planning permission and requesting our consultation advice. We note that the development does not appear to impact directly on any conservation areas, scheduled monuments or highly designated heritage assets, and therefore on the basis of our understanding of the present scope of the work we do not feel that it is essential for English Heritage to provide more detailed advice.

We recommend however that the County Archaeological Officer, Conservation Officer and relevant amenity societies be invited to give more detailed advice on the proposals with respect to any impacts upon heritage, and that the application should be determined in accordance with national and local policy guidance, and on the basis of your specialist conservation advice.
